 - b. **Note: pick either class B or C, not both**
- C. Purebred Bred & Owned Yearling Female, born on or after Jan. 1, 2009
 - a. Registered /tattooed purebred or fullblood Simmental female
 - b. **Exhibitor must be breeder & present owner of entry as verifiable on the CSA registration paper**
- D. Purebred 2 yr Old Female, born on or after Jan. 1, 2008
 - a. Registered/tattooed purebred or fullblood Simmental female
 - b. Natural 2010 registered/tattooed purebred of fullblood calf must be shown
- E. Purebred Mature Female, born before Jan. 1, 2008
 - a. Registered/tattooed purebred or fullblood Simmental female
 - b. Natural 2010 registered/tattooed purebred or fullblood calf must be shown
- F. Purebred/Commercial Bull Calf, born on or after Jan. 1, 2010
 - a. Registered/tattooed purebred, commercial or fullblood Simmental male
- G. Commercial Heifer Calf, born on or after Jan. 1, 2010
 - a. Crossbred/ Percentage Simmental female
- H. Commercial Yearling Female, born on or after Jan.1, 2009
 - a. Crossbred/Percentage Simmental female
- I. Commercial 2 yr. Old Female, born on or after Jan.1, 2008
 - a. Crossbred/Percentage Simmental female
 - b. Natural 2010 calf must be shown at side
- J. Commercial Mature Female, before Jan.1, 2008
